The Significance of Gender Research in the context of Nigeria's Socio-political and Economic Landscape¹

Abstract

The ability of gender research to illuminate systemic inequalities, inequities and inform policy that will address the deep -rooted structural imbalance embedded in the Nigerian society can not be over emphasized. By examining patterns of power, privilege, and discrimination based on gender, gender research uncovers how socio-political and economic systems perpetuate inequalities, marginalization and privilege groups in our society. It in within this context that this paper proposed some strategies to address this disparities in order to foster more inclusive development. The overall aim of this paper is to demonstrate the role of gender research in the development and implementation of policies and legislation aimed at promoting gender equality. Based on lived experiences across Nigeria ethnic communities, the paper challenged stereotypes and discriminatory practices and seek to give voice to those who have been historically silenced and/or overlooked. The study attempts to answer the following questions: what is the role of men and women in traditional societies including the impact of indigenous beliefs and practices on gender relations and the impact of colonial legacies on gender shifts? What are the gender dynamics in the post-independence era including the impact of military rule, civil wars, and economic shifts from agrarian to capital economy on gender roles? To what extent has contemporary modern challenges and evolving perspectives promoted gender disparities in education, health, politics, and economy in contemporary Nigeria? What is the influence of globalization and international gender rights movements on Nigeria society? How has the various religious beliefs shaped gender norms in Nigeria, and the interplay between practices and gender rights? The conclusion arising from this paper is there is need to promote gender research to urgently address the myriads of socio-political, religious and economic issues that promote social injustice, inequalities, inequities and marginalization in our contemporary society. Some strategies and policy recommendations for addressing these disparities to foster more inclusive development in Nigeria were proposed.


Introduction to Nigeria's rich tapestry of ethnicities, languages and traditions

Understanding Gender: Definitions and Paradigms

Understanding Basic Gender concepts

Sex: Sex refers to the biological characteristics that define individuals as male, female, or intersex (Muehlenhard, and Peterson, 2011). These biological factors typically include chromosomes, hormones, and reproductive anatomy. While sex is often perceived as binary (male or female), it is more accurately understood as a spectrum encompassing a range of biological variations. Intersex individuals, for example, may possess physical traits that do not fit typical definitions of male or female. Additionally, the concept of sex is distinct from gender, as biological characteristics do not necessarily determine an individual's gender identity or expression.

Gender: Gender refers to the social, cultural, and psychological attributes, behaviors, and roles that societies construct and associate with masculinity and femininity. Unlike sex, which is biologically determined, gender is a socially constructed concept influenced by factors such as culture, history, and individual identity (Muehlenhard, and Peterson, 2011). Gender is fluid and multifaceted, encompassing a spectrum of identities beyond the traditional binary of male and

female. Gender roles and expectations vary across different cultures and time periods, and individuals may identify with or express their gender in diverse ways. Understanding gender as a social construct allows for the recognition of diverse experiences and challenges related to gender identity and expression.

Gender Roles: Gender roles refer to the societal expectations, norms, and behaviors that are associated with being male or female within a particular cultural context. These roles dictate how individuals are expected to behave, interact, and perform tasks based on their perceived gender. Gender roles are deeply ingrained in societies and often reinforce stereotypes and inequalities. Traditional gender roles may limit individuals' opportunities and constrain their freedom to express themselves authentically. Challenging and transcending rigid gender roles is essential for promoting gender equality and creating inclusive environments where individuals are free to pursue their interests and aspirations irrespective of gender norms (Lindsey, 2020).

Gender Identity: Gender identity refers to an individual's deeply felt sense of their own gender, which may or may not align with the sex they were assigned at birth (Egan and Perry, 2001). Gender identity is internal and may be experienced as male, female, both, neither, or somewhere along the gender spectrum. Gender identity is a fundamental aspect of selfhood and may develop independently of biological sex or societal expectations. Transgender and non-binary individuals, for example, may experience gender dysphoria when their gender identity does not align with the sex they were assigned at birth (Murawsky, 2023). Respecting and affirming individuals' gender identities is essential for fostering inclusivity and supporting the well-being of all individuals, regardless of their gender expression.

Gender Blind: Gender blindness refers to a state of ignoring or overlooking gender differences and disparities in various contexts, such as policies, programs, or decision-making processes. When an approach or system is gender blind, it fails to recognize the distinct needs, experiences, and contributions of different genders, resulting in the perpetuation of inequalities and the exclusion of marginalized groups. While gender blindness may arise from a lack of awareness or understanding of gender dynamics, it can also stem from entrenched biases or a reluctance to address systemic inequalities. Gender-blind approaches often reinforce existing power structures and perpetuate discrimination, as they fail to address the root causes of gender disparities. Overcoming gender blindness requires recognizing the importance of gender analysis and integrating gender considerations into all aspects of planning, implementation, and evaluation

Gender Bias: Gender bias refers to the systematic favoritism or discrimination towards individuals or groups based on their gender. This bias can manifest in various forms, including stereotypes, prejudices, and unequal treatment, and it often results in the unequal distribution of resources, opportunities, and power between genders (Bowen and Swim, 2000). Gender bias is deeply ingrained in social, cultural, and institutional norms, shaping attitudes, behaviors, and policies. It can manifest in both explicit and implicit ways, influencing decision-making processes and perpetuating inequalities. Addressing gender bias requires challenging stereotypes,

Gender Exploitation: Gender exploitation occurs when individuals or groups are subjected to unfair treatment, abuse, or exploitation based on their gender. This exploitation can take various forms, including economic exploitation, sexual exploitation, and emotional exploitation, and it often intersects with other forms of discrimination, such as race, class, or ethnicity. Gender exploitation is a manifestation of power imbalances and structural inequalities that disproportionately affect marginalized groups, particularly women and girls (Rafferty, 2023). It reflects broader patterns of oppression and discrimination within society and is often perpetuated by systems of patriarchy, capitalism, and colonialism. Addressing gender exploitation requires dismantling oppressive systems, empowering marginalized groups, and promoting gender justice and human rights.

Gender Gap: The gender gap refers to the disparity or difference between men and women in terms of access to resources, opportunities, and outcomes. This gap can exist across various domains, including education, employment, income, health, and political representation, and it often reflects systemic inequalities and discrimination. The gender gap is a reflection of structural barriers and biases that limit the full participation and potential of women and girls in society (Wang and Degol, 2017). It results from a complex interplay of factors, including social norms, institutional policies, and cultural attitudes. Closing the gender gap requires addressing root causes of inequality, such as unequal access to education and economic opportunities, and implementing targeted interventions to promote gender equity and empowerment.

Gender Equity: Gender equity refers to the fair distribution of resources, opportunities, and rights between genders, with a focus on addressing historical and systemic inequalities. Unlike gender equality, which aims for sameness, gender equity recognizes that different groups may require different levels of support to achieve equality and seeks to rectify existing disparities. Gender equity acknowledges the diverse needs and experiences of individuals and aims to create conditions where all genders can thrive and reach their full potential. It involves identifying and dismantling barriers to equality, such as discriminatory laws, policies, and practices, and implementing measures to promote fairness and justice (Panda et al., 2024) Gender equity recognizes that achieving equality may require targeted interventions and affirmative action to address historical disadvantages and ensure inclusivity.

Gender Equality: Gender equality refers to the state of equal rights, opportunities, and treatment for all genders, without discrimination or bias. It encompasses the principle of fairness and justice and recognizes that individuals should not be disadvantaged or privileged based on their gender (Nanni, 2023). Gender equality is a fundamental human right and a cornerstone of sustainable development. It entails eliminating discriminatory practices and policies, challenging harmful stereotypes and attitudes, and promoting equal participation and representation in all spheres of life. Achieving gender equality requires concerted efforts at the individual,

Women Empowerment: Women empowerment refers to the process of enabling women to realize their full potential, exercise their rights, and achieve greater autonomy and control over their lives (Sahay,1998). It involves enhancing women's agency, voice, and participation in decision-making processes and addressing the structural barriers that limit their opportunities and freedoms. Women empowerment is essential for advancing gender equality and promoting sustainable development (Pathania, 2017). It encompasses various dimensions, including economic empowerment, political empowerment, social empowerment, and psychological empowerment. Empowering women not only benefits individuals but also contributes to broader societal progress, as women play critical roles as caregivers, community leaders, and agents of change. Empowerment strategies may include providing access to education and training, promoting economic opportunities, ensuring reproductive rights and healthcare access, and challenging gender norms and stereotypes that perpetuate inequality.

Gender Mainstreaming: Gender mainstreaming is a strategy aimed at integrating a gender perspective into all stages and levels of policymaking, planning, implementation, and evaluation. It involves systematically analyzing the differential impacts of policies, programs, and projects on women, men, and gender-diverse groups, and adjusting interventions to promote gender equality and address gender disparities (Lombardo and Mergaert, 2013). Gender mainstreaming recognizes that gender equality is not a separate issue but rather an integral component of all areas of development (Walby, 2005). By incorporating a gender perspective into decision-making processes, gender mainstreaming seeks to ensure that policies and programs benefit all members of society equally and address the specific needs and concerns of different genders. This approach helps to challenge gender stereotypes, dismantle discriminatory practices, and promote the full participation and empowerment of women and marginalized genders in all aspects of life.

Key elements in gender mainstreaming include:

- a. **Policy integration** Gender mainstreaming requires integrating gender considerations into all stages of policy development, from agenda-setting and formulation to implementation and monitoring. This involves conducting gender analyses to identify gender gaps, inequalities, and barriers, and incorporating gender-sensitive indicators to track progress towards gender equality goals.
- b. **Institutionalization** Gender mainstreaming involves establishing institutional mechanisms and structures to support the integration of gender into decision-making processes.
- c. **Participation and representation** Gender mainstreaming emphasizes the importance of ensuring the meaningful participation and representation of women and marginalized genders in decision-making processes. This involves creating opportunities for women's voices to be heard, promoting women's leadership and

representation in political and decision-making bodies, and engaging with diverse gender perspectives in policy dialogue and consultation processes.

d. Capacity Building - Gender mainstreaming requires building the capacity of policymakers, planners, and practitioners to effectively incorporate a gender perspective into their work. This may involve providing training on gender analysis and mainstreaming techniques, developing gender-sensitive tools and methodologies, and fostering a supportive organizational culture that values gender equality and diversity.

Notably, gender mainstreaming is a transformative approach that seeks to address the root causes of gender inequality and promote systemic change. By embedding gender considerations into policy and practice, gender mainstreaming contributes to building more inclusive, equitable, and sustainable societies where all individuals can realize their full potential regardless of gender. However, it also requires sustained political will, commitment, and resources to overcome resistance and institutionalize gender equality principles effectively

Most of these gender concepts are interconnected and complex, shaping institutions, and individuals' experiences and interactions within society. Understanding these concepts requires recognizing the diversity of human experiences and identities and challenging rigid stereotypes and norms that perpetuate inequalities. Embracing gender diversity and promoting inclusivity are essential steps towards creating a more equitable and just society for all.

WID - GAD Paradigm Shifts

Why Gender and Development?

The paradigm shift towards sustainable development requires a renewed focus on people-centered development that prioritizes the expansion of capabilities, the eradication of poverty, and the reduction of all types of inequalities, including gender inequalities. To eradicate poverty, growth and development strategies must be inclusive, equitable, and sustainable, while the equal participation of women is a prerequisite for achieving sustainable development. Thus, gender equality is intrinsically linked to sustainable development and it is vital to the zof human rights for all (Aina, 2011). As a fundamental human right, gender equality is enshrined in various international and regional instruments ratified amongst member states. For example, the non-discriminatory principle inherent in the Nigeria constitution takes its root from the Universal Declaration on Human Rights of 1948. Thus, gender-based discrimination is treated as a violation of the principle of equality before the law, while by extension, gender equality (in particular, equal participation of all citizens in popular democracy) is at the bedrock of good governance.

The overall objective of gender equality is a society in which women and men enjoy the same opportunities, rights, and obligations in all spheres of life. According to a UNFPA Report (2022), equality between men and women exists when both sexes are able to share equally in the

distribution of power and influence; have equal opportunities for financial independence through work; enjoy equal access to education and the opportunity to develop personal ambitions, interests, and talents; share responsibility for the home and children, and both are completely free from coercion, intimidation, and gender-based violence both at work and at home.

It is important, however, to acknowledge that in most cases where gender inequality exists, it is generally women who are excluded or disadvantaged in relation to decision-making and access to economic and social resources. Discrimination against women and girls - including gender-based violence, economic discrimination, reproductive health inequities, and harmful traditional practices - remains the most pervasive and persistent form of inequality in the world today. A major component of the global gender equality agenda, therefore, is the empowerment of women, with a focus on identifying and redressing power imbalances, economic inequality, educational gaps, and other manifestations of inequality across sectors.

It is now realized globally that issues of women's human rights are essential for any meaningful development to take place. Apart from social justice, which demands equal opportunity for all citizens, it is smart economics to plan with both halves of one's population because it benefits society as a whole (British Council, 2012). Investing in women and girls does not only create a positive development cycle, the opposite is also adjudged to be true, that is, a country that fails to empower half of its population will suffer from lower productivity, slower economic growth, and weaker development outcomes.

Development standpoints on women's needs and welfare are helping to refocus attention on the situation of girls across nations. If resources reach women and girls early, transformative change can happen quickly, while poverty can be stopped before it starts (DFID, 2013). The invincibility of this standpoint can be summarized in the UNDP perspective that a development that is not **engendered is endangered (Human Development Report**, 1995).

A gender-transformative perspective, rooted in the 'Gender and Development (GAD) approach, is now adopted to change the narrative of continued marginalization of women. It criticized how (global) capitalism, patriarchy, and other forms of institutional structures of social oppression continue to keep women/girls in marginalized and subordinate positions. According to Kabeer (2005), GAD approach signified gender relations as power relations and thereby requiring that marginalized women be empowered while also challenging the mainstream development paradigm, which continues to support the structure of gender inequalities in society. A gender transformative framework (using gender, rights, and equity lens) is critical of the neoliberal development paradigm and aims at transforming paradigms, institutions, and social relations in favor of the marginalized group (women, children, and persons living with all forms of vulnerabilities).

The WID - GAD Frameworks

WID framework emerged in the early 1970s, as a response to the failure of the mainstream development practice to address women's roles and contributions to the development process. WID advocates the integration of women's interests and concerns in the development processes, while also recognizing the important contributions women make to economic development, that is, recognizing their productive roles, and accounting for these in development models.

The WID approach was increasingly criticized because it did not attempt to change existing socio-cultural gender biases. Furthermore, female-focused projects did not always result in improved economic conditions, even for the women themselves. For example, most incomegenerating projects were found to be ineffective, while women-focused production/technology projects often added to rather than eased women's workloads and involved trade-offs with other responsibilities (Razavi and Miller, 1995: 13). WID, therefore tended to reinforce stereotypical roles of women, and often seen as paternalistic and top-down approach to development. As a result, by the mid-1980s, GAD had emerged as the successor to WID, with an underlying platform of explicitly challenging gender imbalances.

GAD, in contrast to WID, does not concentrate its attention exclusively on women, but examines the social construction of gender and the assignment of specific roles, responsibilities, and expectations to women and to men. The GAD approach aims to understand the power dynamics between men and women in different contexts arguing that it is only by understanding gender power relations that development can empower women and thereby create positive and sustainable socio-economic change (see Table 1.1). GAD places critical importance on the use of gender analysis to gather and analyse information on social roles based on gender, in order understand and redress gender-based inequities through development interventions.

Critiques of GAD have argued that despite its conceptual power, it has been practically applied in donor organizations in ways similar to WID, with a primary focus on women through similar interventions such as micro-credit, education and health, while less attention is given to the longer-term goal of challenging gender-based inequalities. In such interventions, gender has become a synonym for women, with little substantive analysis of or investment in redressing gender inequalities between men and women. The success of the GAD framework in bringing about gender transformative change, depends on the extent to which the gender mainstreaming policy is supported and translated to concrete actions, otherwise, for many organizations and institutions, what is supposed to be a vibrant GAD model, remains nothing but a WID model in reality, while the gender mainstreaming intent easily evaporates. This has been attributed to lack of political will and high-level leadership to support a system-wide gender mainstreaming options. Competing development priorities in the mid-2000s, including, current attention on good governance, poverty reduction, new aid modalities, HIV/AIDS, anti-corruption, climate change, security and humanitarian action, among others, corroded attention on system-wide

Annals of the Social Science Academy of Nigeria Vol. 23 January–December 2019/2023 gender mainstreaming. This led to a general poor implementation of Gender Policies, where they existed. Notably, the emergence of the Sustainable Development Goals (2015 - 2030), brought about renewed vision on gender mainstreaming and gender integration into policies, programs and projects.

Historical Lens: Gender Roles and Relations in Pre-Colonial Nigeria

A glimpse into traditional societies and the roles of men and women

This section provides a historical overview of gender roles and relations in pre-colonial Nigeria, offering insights into the social organization, norms, and expectations surrounding gender within traditional societies. It explores the distinct roles and responsibilities assigned to men and women, their contributions to community life, and the ways in which gender roles were shaped by cultural, economic, and environmental factors. Examining gender roles in pre-colonial Nigeria offers valuable insights into the historical roots of contemporary gender dynamics and provides a nuanced understanding of how gender identities and relationships were constructed and negotiated within indigenous societies (Egbuchulem, 2024). By delving into the division of labor, familial structures, and systems of authority, this section illuminates the diverse ways in which men and women participated in and contributed to the social, economic, and political life of their communities. Additionally, it highlights the complex interplay between gender, kinship, and social status, shedding light on the intersectional nature of gender inequality and the ways in which it intersected with other axes of identity such as age, class, and ethnicity.

Across Nigeria's diverse ethnic groups, traditional societies exhibited varying gender roles and relations (Kritz,1999). For instance, among the Igbo people of southeastern Nigeria, women often played central roles in agriculture and trade, contributing significantly to the household economy. In Igbo society, women were responsible for cultivating crops such as yams, cassava, and vegetables, while men typically engaged in activities such as hunting and clearing land. However, both men and women participated in decision-making processes within the family and community, with women holding considerable influence in matters concerning the household.

These examples illustrate the diverse ways in which gender roles were constructed and negotiated within traditional Nigerian societies. While there were commonalities in terms of the division of labor and familial structures, there were also variations shaped by factors such as geography, ecology, and cultural practices. Despite differences in specific roles and responsibilities, both men and women across Nigerian ethnic groups played vital roles in sustaining their communities' social and economic life. Understanding these traditional gender roles provides insights into the historical roots of contemporary gender dynamics and

literacy rates and access to formal employment opportunities among the Edos, just as it is with other Nigerian ethnic groups.

Colonial education systems thus played a significant role in shaping gender roles (Ellis, 2020). While education was initially limited and often segregated by gender, colonial policies eventually prioritized the education of boys over girls, further limiting women's access to formal education and perpetuating gender disparities in literacy and skill development. Additionally, colonial legal systems introduced laws and regulations that often discriminated against women, restricting their rights to property ownership, inheritance, and political participation.

In summary, colonial rule in Nigeria disrupted traditional gender roles and relationships across various ethnic groups by reinforcing patriarchal norms, introducing new economic structures, and imposing legal systems that often discriminated against women.
